DATA SUBJECT APPLICATION FORM (the "FORM")

Pursuant to the Privacy Notice of Cengiz Holding A.Ş. ("Cengiz Holding"; "Company") and in accordance with Article 11 of the Turkish Personal Data Protection Law No. 6698 ("Law No. 6698"), you may submit your requests within the scope of your rights as a Data Subject by completing this Form and delivering it to our Company through one of the methods specified below.

Your requests regarding your personal data will be responded to as soon as possible and in any event within thirty (30) days from the date on which your application is received by our Company.

In accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller, the Data Subject must include the following information in the application:

- First and last name
- Signature (if the application is submitted in writing)
- Turkish Identification Number (or nationality and passport number / identification number for foreign nationals)
- Residential or workplace address for notification purposes
- If available, email address, telephone number and fax number
- Information regarding the subject matter of the request

The Data Subject must clearly and explicitly specify the right they wish to exercise under Article 11 of Law No. 6698. Relevant information and supporting documents must be attached to this Form.

The request must relate to the applicant personally. If the application is submitted on behalf of another person, the applicant must be duly authorised and such authorisation must be documented.

If the application concerns special categories of personal data, the applicant must be specifically authorised in accordance with Article 10 of the Regulation on Personal Health Data. The application must include identity and address details and be accompanied by documents verifying identity.

Requests submitted by unauthorised third parties on behalf of another person will not be evaluated.
